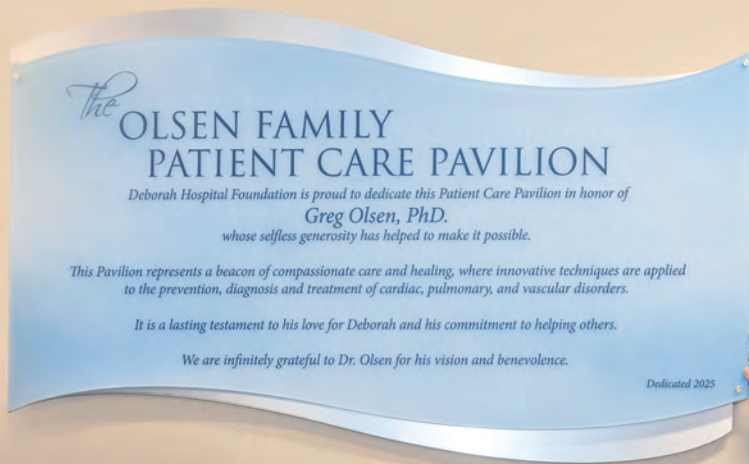


A Message from the Chairman of the Board

Thank you for being an integral part of our journey and for making a tangible difference in the lives of so many.

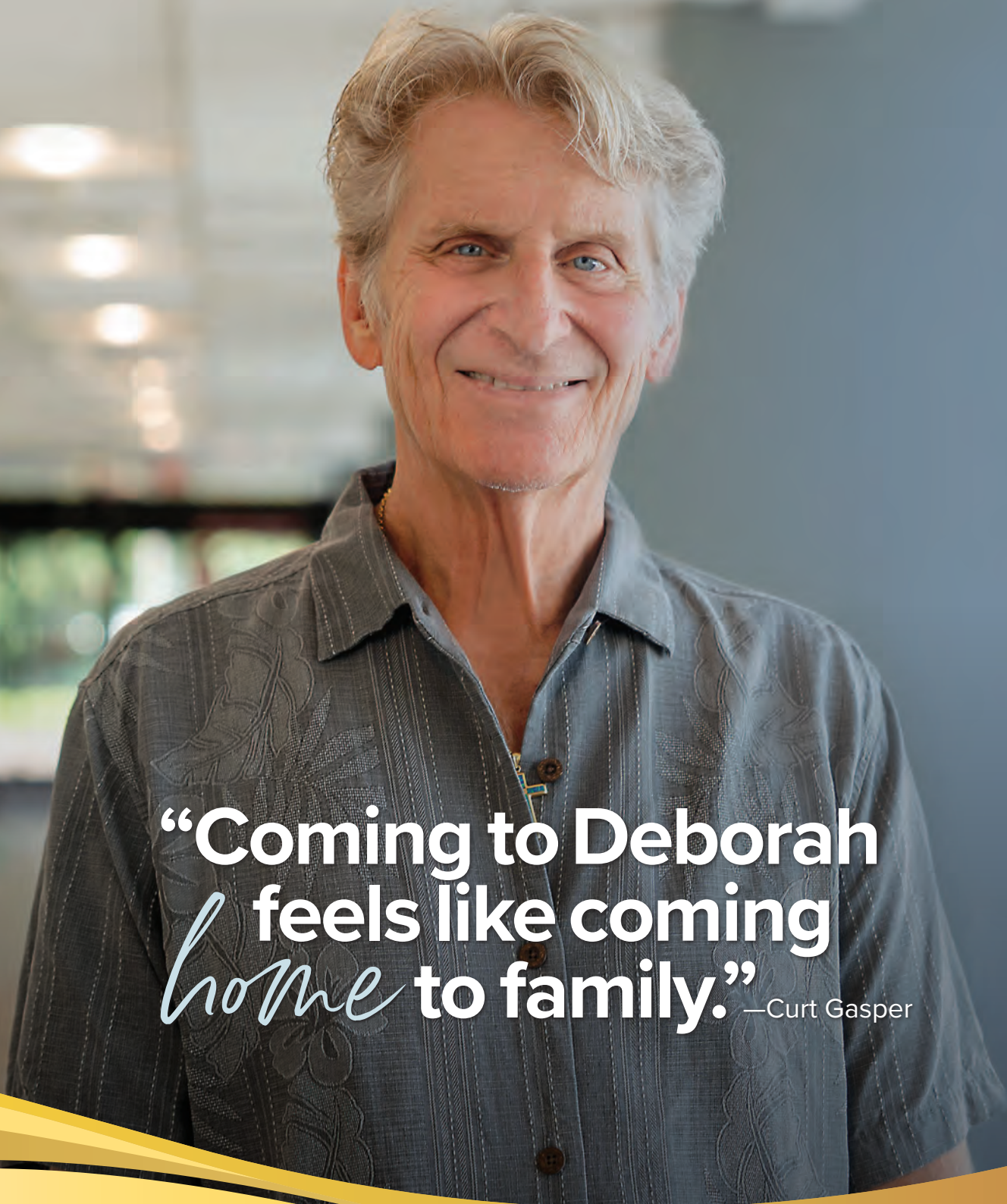

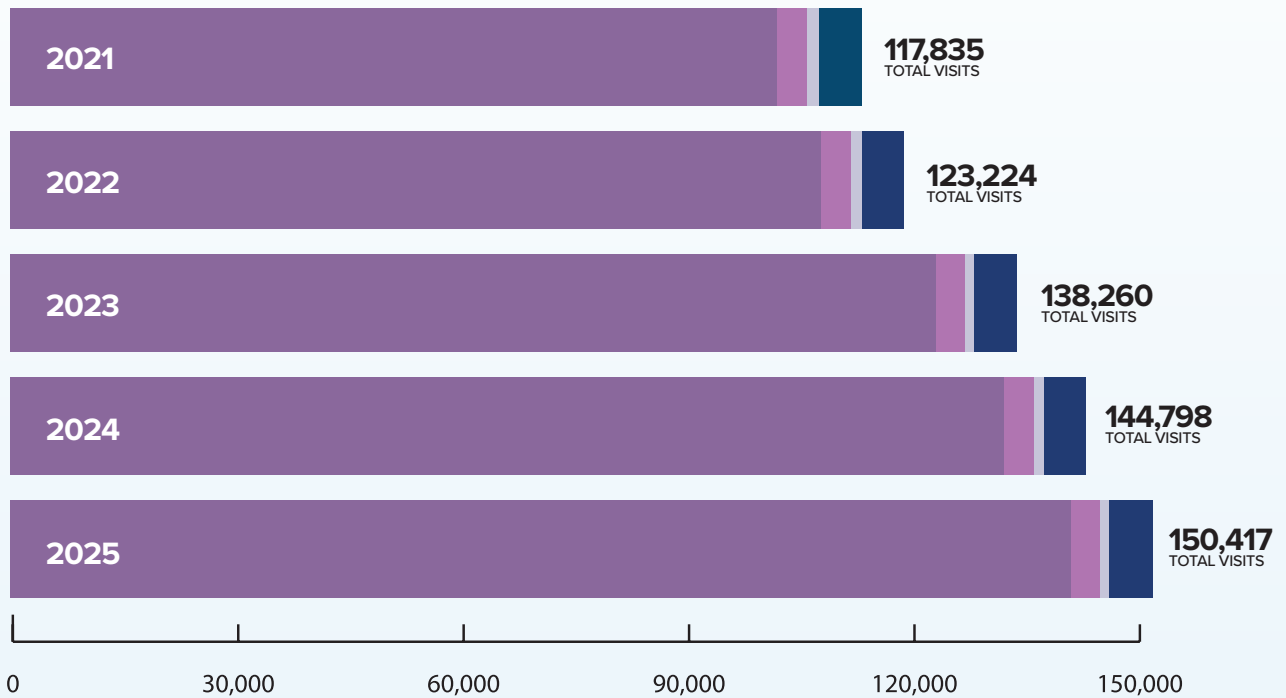

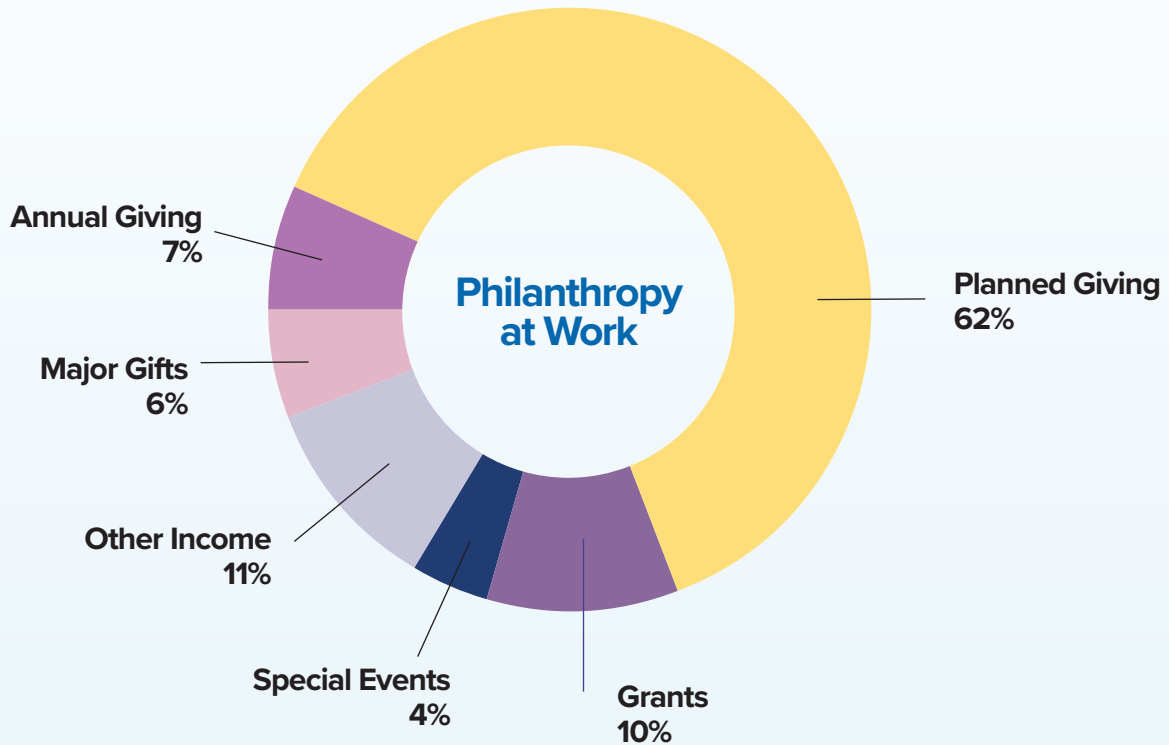

On May 14th, nearly 200 donors and invited guests attended the dedication of The Olsen Family Patient Care Pavilion at Deborah Heart and Lung Center. This event marked a transformative moment for Deborah, representing a significant step forward in our commitment to providing world-class cardiac, pulmonary, and vascular care. The new building is a key part of **Deborah100: The Project**.

Jim Andrews, President and CEO of Deborah Heart and Lung Center, emphasized the importance of the expansion. “The Olsen Family Patient Care Pavilion is more than just a building; it represents a natural step in Deborah’s evolution,” he stated. “It embodies our dedication to people-centered care, providing an environment that promotes healing, dignity, and hope. This Pavilion will empower our exceptional clinical team to continue delivering the life-saving care that defines Deborah.”

With the opening of the new pavilion, Deborah is elevating the inpatient experience through 36 private suites. These thoughtfully designed spaces reflect our commitment to personalized, comfortable, and safe care, aligning with the highest standards in healthcare. Each suite is equipped with sophisticated negative/positive air pressure systems, empowering our clinical team to provide optimal isolation for immunocompromised patients and effectively control infectious disease. The new patient floors embrace a wellness philosophy, centered on family involvement and a healing ambiance created by abundant natural light, soothing colors, and tactile elements. Features such as sound-dampening materials and enhanced natural light contribute to a more peaceful and restorative environment, potentially leading to shorter hospital stays. Loved ones will appreciate the convenience of a daybed/window seat, while patients can enjoy large picture windows overlooking the serene wooded campus,

a personal flat-screen television, a private bathroom and shower, individual lighting controls, a cutting-edge adjustable medical bed, and secure storage. Medical necessities, including gases and advanced technology, are intentionally concealed to promote a calm and reassuring atmosphere for our patients.

This innovative campus expansion was made possible by a lead gift from Greg Olsen, the largest donor to **Deborah100: The Campaign**. The Pavilion is dedicated in his honor, acknowledging his significant impact on future patients and families.

Lem Burnham, Chairman, Board of Trustees of Deborah Heart and Lung Center, highlighted the collaborative effort behind the project. “Today, we celebrate not only a magnificent new facility but also the power of community and shared purpose,” Dr. Burnham noted. “This Pavilion strengthens Deborah’s position as a leading institution in cardiovascular and pulmonary care.”

Marking a significant milestone

In May 2025, Deborah proudly dedicated the Olsen Family Patient Care Pavilion with a special ribbon-cutting ceremony. Within days of receiving State approval, all 36 private patient suites were fully occupied—bringing a new era of comfort, privacy, and personalized care. “From day one, patients expressed their enthusiasm for the modern, thoughtfully designed spaces and the compassionate care delivered by our dedicated team,” said Jim Andrews, President & CEO, Deborah Heart and Lung Center and Deborah Hospital Foundation.

“It is hard enough for an independent specialty hospital to compete with the multi-billion dollar mega-systems without also carrying the burden of an aging infrastructure. Through our donors’ philanthropic support and grant funding organizations, we have been able to complete a critical phase in our campus expansion project,” Andrews added.

With a reimagined floor layout, Deborah’s new private patient suites are designed to optimize both patient care and operational efficiency. The improved structured flow maximizes available space—creating larger, more comfortable patient suites, improving accessibility for medical teams, and enhancing direct access to patient-point-of-care. This allows our Deborah team to individualize and enhance a patient’s experience during their stay—ensuring the best medical outcomes.

“Although the floors are specific to an area of need, each floor will be adaptable to care for all patients across a range of medical care services,” said Geralyn Angelo, RN, Director of Medical-Surgical Nursing Services.

The successful opening of the Olsen Pavilion proves that modern infrastructure is critical to delivering the world-class care Deborah is known for. But our work is not finished. Phase 2—renovating the remaining patient care floors, along with observation and the surgical recovery units—is the next vital step to ensure every patient on our campus receives care in a state-of-the-art environment.
